Director of Policy & Research Report – Jennifer English



As Research and Communications Coordinator I have had the opportunity to work closely with the Chamber's advocacy committees to provide research support, contribute to policy development, and assist with committee projects and initiatives. Working with these committees has allowed me to develop a broader understanding of the key issues at the local, provincial, and federal levels, and has contributed to growth in my research abilities.

The main project for this year's Municipal Government Affairs Committee has been to develop a detailed policy brief that focuses on some of the issues that were raised in the Municipal Candidate Questionnaire that had been undertaken by the previous year's

committee. Scheduled to be presented to Fredericton City Council in early June, this brief discusses key issues like fiscal policy, economic development, affordable housing, and public transportation. I'll be working with next year's volunteers to ensure that these issues continue to be a priority.

The Economic Development Committee began its work this year by collaborating with a number of community agencies and organizations – including Enterprise Fredericton, the Knowledge Park, and the Multicultural Association of Fredericton – and used these collaborations to launch two key initiatives. The first, a Business Immigrant Mentorship Program, has begun with the hiring of a Project Coordinator. The second, an Accommodations Sector Task Force, has held two encouraging early meetings. I will be working closely with both the Project Coordinator for the Mentorship Program and members of the Task Force in the coming months, and welcome the opportunity to continue my involvement in these initiatives.

The Federal/Provincial Government Affairs Committee has also had a busy year. With its prime focus on policy, the committee has been involved in four main projects this year: supporting the policies outlined in the Canadian Chamber of Commerce's Canadian Business Agenda; submitting a brief to provincial Finance Minister Victor Boudreau as part of the pre-budget consultation process; hosting a dinner with Minister Boudreau following the announcement of the 2009-2010 budget; and collaborating with the Saint John Board of Trade and the Greater Moncton Chamber of Commerce on a joint submission to the Canadian Chamber as part of its annual policy resolution process. I'll be continuing to work on this policy submission in the coming weeks, and appreciate the feedback committee members have provided.

This year the Chamber formed its President's Committee on Physician Recruitment in response to concerns our members had voiced on physician shortages. With volunteers from government and a wide range of private sector companies, the committee has identified a number of priority areas to address, including spousal employment, policy and research, and communications. I have worked with members of this committee to organize an event for local residents and physicians, develop a website with information on the city, and will soon be helping to create a series of videos showcasing the city. I look forward to continuing to work with this committee to find ways to

In addition to my work with the Chamber's committees, I have also had the opportunity to participate in a number of external projects and initiatives. I contributed to Fredericton's application to the Intelligent Communities Forum, provided research support to the Capital Region Tourism Association, and am an active member of the City of Fredericton's Affordable Housing Committee.

This month I began my role as Director of Policy and Research, which will allow me to increase the Chamber's capacity to research and develop policy and provide me an opportunity to become involved in a greater number of policy initiatives. My work with the Chamber has been a great experience, and I look forward to this opportunity to broaden my Chamber involvement.



Event Manager's Report – Jennifer Phillips

If you need to network, make contacts, spread the word of an exciting new launch at your business, contact the Fredericton Chamber of Commerce to register for an upcoming event.

We offer over 50 events throughout the year. At each of these events there is the opportunity to meet new people and exchange business cards. The number of clients that you could possibly recruit may range from a crowd at our Business after Hours of 100-125 people or to a crowd of over 1000 at our State of the Province Address.

One of our successful monthly programs is our Business after Hours. This is an excellent chance for the host to showcase their business in a relaxed manner. We are booked until the end of 2010 but are taking a waiting list for 2011 and onward. The mix of people allows for a friendly environment for our new members to the Chamber. Our Productivity Matters Education Series, which is a monthly event from 7:30am-9:00am. We receive a number of requests for speakers to come in and talk on different areas from Human Resources to Sales, IT to Networking. The Art of Networking Seminar and Members Reception is an annual event, the seminar is for members and gives them the opportunity to learn more about networking. The Members Reception which follows gives everyone a chance to use his or hers newly acquired skills.

On a larger scale, the Chamber annually hosts seven major events, which draw crowds from 250-1000 people. Such as the Annual Golf Tournament, Business Expo, State of the City Address, Business Excellence Awards, State of the Province Address, Distinguished Citizens Awards and our Annual Banquet. The different major events offer a variety of venues appealing to different crowds.

Project Coordinator's Report - Ben Griffin

After immigrating to Fredericton in August 2008 from the UK and completing the first year of my Masters program at UNB, I joined the Chamber in early May to start my role as Project Coordinator overseeing our new Business Immigrant Mentorship Program. Having only recently begun I do not have a conventional report on my activities, rather I am writing to express my sincere belief in the potential and necessity of this new initiative, and outline our intentions.

As a recent immigrant to the province I am aware of the problems faced by those seeking to establish new lives here. There is a great challenge in identifying business openings as part of the assimilation process, and I am confident that this mentorship initiative can help ease the burden. It will be the role of this program to select professional mentors from our existing Chamber membership and work to pair them up with new business immigrants to the area. The mutual exchange of ideas and increasingly diverse network of contacts that this program will facilitate should enable our new immigrant professionals to better integrate with our existing community. The mentees, meanwhile, will be encouraged to share their cultural background and work history with their mentors, offer fresh perspectives on the Canadian workplace, and develop their own networks of business contacts for the future. One of my long-term goals is to encourage previous mentees to mentor new business immigrants in the future. They can lean on their experiences of adapting to life in Fredericton, and the support of this program, to offer unique testimony to the impact of this venture.

We are confident that this approach will lead to a mutually beneficial experience, and we welcome volunteers from our membership as we begin preparing for our first cohort this coming August. I look forward to reporting on the success of this program next year, and I am excited to meet with our members in the coming months as we prepare for the first cohort of what I hope will be many.

This year's Federal/Provincial Government Affairs Committee has focused on four projects: supporting the policies outlined in the Canadian Chamber's Canadian Business Agenda; submitting a brief to the provincial Finance Minister as part of the pre-budget consultation process; hosting a dinner with Finance Minister Victor Boudreau following the release of the 2009 provincial budget; and collaborating with the Greater Moncton Chamber of Commerce and the Saint John Board of Trade on a joint policy submission to the Canadian Chamber of Commerce.

The committee's first project was to support the policies outlined in the Canadian Business Agenda. Published annually by the Canadian Chamber of Commerce, the Canadian Business Agenda identifies issues that relate to prosperity and competitiveness in the Canadian business environment. Since the policy issues addressed in the Agenda – from fiscal policy and trade to climate change and Canada-U.S relations – directly impact our members, the committee opted to voice its support for the Agenda and its recommendations. Letters were written to the federal Minister responsible for each issue, and copies were sent to Greg Thompson and Keith Ashfield. These letters are available on the Chamber website.

The committee also participated in this year's pre-budget consultation process, developing a brief that outlined the Chamber's observations on the state of the local economy and made recommendations around careful deficit management and strategic spending in key areas like infrastructure, health, and education. Anthony Knight presented the recommendations at the Fredericton consultation in February, and the written brief was submitted to the Department of Finance. The full text of this brief is also available in the Policy Briefs section of the Chamber website.

The FPGA committee was instrumental in organizing the first Budget Dinner with the Minister of Finance. A joint initiative of the Chamber and the New Brunswick Real Estate Association, the Budget Dinner is hosted on the evening of the release of the provincial budget, and gives attendees an opportunity to learn the details of the budget first hand, and to pose questions about the content of the budget. The Chamber anticipates that the Budget Dinner will become an annual event.

The committee's most recent project has been to collaborate with the Saint John Board of Trade and the Greater Moncton Chamber of Commerce on a joint policy submission to the Canadian Chamber of Commerce. Focusing on infrastructure funding and airport fees at National Airport System (NAS) airports, this policy will compete with policies from Chambers across the country as part of the Canadian Chamber's annual policy resolution process.

The main project for this year's committee has been a detailed policy brief that focuses on some of the issues that were raised in the Municipal Candidate Questionnaire developed by the 2007-2008 Municipal Government Affairs Committeeduring the May 2008 municipal election. This brief, which is scheduled to be presented to Fredericton City Council in late May, discusses a series of matters that are of great importance to the Chamber's membership. The following is a summary of this brief; the full text is available on the Chamber website.

Fiscal Policy – The Chamber encourages the City of Fredericton to work to find ways to be more efficient with program spending in order to minimize the tax burden on businesses and individuals.

Transportation – The Chamber believes that an efficient public transit system is essential for any growing community, and feels there are several opportunities for Fredericton to expand and improve its current service. Key suggestions include continuing to work with UNB to reach an agreement for a U-Pass, offering service to new areas of commercial and/or residential development, and establishing targets for an accessible transit system.

Economic Development – Although many of our members continue to report that their businesses are faring well, we know that Fredericton is likely to face challenging times ahead. In order to prepare for this challenge the Chamber advises the City to continue to pursue partnerships and collaborations with the provincial and federal governments to support economic development and growth in the community.

Affordable Housing – An active member of the City's Affordable Housing Committee, the Chamber recognizes the relationship between access to affordable housing and workforce participation, as well as a variety of other social and economic benefits. We encourage the City to continue working with private developers to resolve barriers to affordable housing development and to work with the provincial government to create an inventory of available land for interested developers.

The Committee is committed to working collaboratively with the City of Fredericton and maintaining and developing a positive and productive relationship on behalf of the business community.



Economic Development Committee Report - Andrew Steeves (ADI Ltd) - Chair

The committee has collaborated with a number of organizations including Enterprise Fredericton, Team Fredericton, the Knowledge Park, and the Multicultural Association of Fredericton. By connecting with these organizations, the committee has built a solid understanding of what is happening in the city with respect to economic development. This understanding has enabled the committee to build upon existing efforts that are being undertaken in the community.

One of the projects to emerge from these discussions is the recently established Business Immigrant Mentorship Program, a first of its kind in New Brunswick. Committee members have noted that immigrant entrepreneurs are in need of opportunities to meet with, learn from, and engage in dialogue with established local business people, and that the Chamber is ideally positioned to facilitate this kind of relationship. The committee is pleased that a Project Coordinator has been hired to oversee this project, and that the Chamber intends to begin matching mentors and mentees by the early fall.

Another important initiative related to the committee's work is the Accommodations Sector Task Force. Comprised of local hotel operators from the Greater Fredericton Area, the Accommodations Sector Task Force was formed after representatives from the Economic Development Committee met with members of the accommodations sector to examine the benefits of a coordinated approach to key industry issues. Early meetings of the Task Force have been encouraging, and the Chamber looks forward to this group's continued success.

In partnership with the Regional Health Authority, the committee has developed a six-point action plan to achieve its primary objective: to make Fredericton a destination of choice for physicians.

Office space

The committee is working with Enterprise Fredericton to develop a physician-specific option to the Invest Fredericton website. This option would allow physicians to search available commercial property in the Greater Fredericton area according to key criteria such as proximity to the hospital, other physicians, and pharmacists.

Administrative management

We recognize that few physicians are interested in the administrative aspects of operating a practice, and plan to connect new physicians with local companies who specialize in managing these functions.

Spousal employment

We have been told that one of the key factors in a physician's decision to practice in a community is the availability of suitable employment opportunities for his/her spouse or partner. The committee has the expertise to assist with this aspect, and will work with spouses and partners to help them find work in their field.

Policy and Research

The success of this initiative will depend largely on our understanding of the factors physicians use to evaluate a community. We are planning a series of discussions with physicians to determine what motivated them to practice in Fredericton and what challenges they have encountered, and to develop policy initiatives around issues that might impact a physician's willingness to practice here.

Communications

It is essential that potential physicians have quick access to information about the city. The committee has developed a website called Go Fredericton (www.gofredericton.ca) that details the city's arts and culture scene,



recreation opportunities, and economy, in addition to providing links to information on real estate opportunities and updates on committee initiatives.
